

# Wilko - Monthly Prize Draw

## Terms & Conditions

1. This document sets out the terms and conditions that apply to participation in the monthly prize draws (the “Prize Draws”)
2. The Promoter reserves the right to change these terms at any time.
3. To enter a Prize Draw, please complete and submit the survey entry form at [www.wilkohaveyoursay.com](http://www.wilkohaveyoursay.com) or phone 0845 5280 200.
4. The prize each month is a £100 Wilko gift card. Gift card terms and conditions can be found on the back of the gift card.
5. There will be one winner drawn each month.
6. The winners will be chosen at random from all completed and valid survey entries and notified within 15 days of the closing date. The prize must be claimed within 14 days of the date of receiving that notification. If the prize is not claimed for whatever reason, a redraw will take place. The Promoter's decision is final and no correspondence will be entered into.
7. The Promoter accepts no responsibility for data corruption, incomplete or illegible entries, or entries which fail to be properly submitted.
8. The draw is open to UK residents aged 18 or over, excluding employees of any company within the wilko family of businesses or InMoment, their immediate families or agents.
9. Winners may be asked to partake in publicity surrounding their win though this is not compulsory.
